Background Information:

Annually in January the Parks, Tree & Recreation Advisory Board considers applications from various organizations applying for funding from the Albany County Recreational Mill Levy administered by the Albany County Recreation Board and the Albany County School Board.

Applications are received from the City of Laramie, Albany County, Rock River and Albany County School District through processes that each agency is responsible to administer. The City of Laramie process uses notification through previous applications, the Laramie Boomerang and City’s website. Applications were due December 17, 2021 at 4:00pm. Presentations to the Parks, Tree & Recreation Advisory Board at their regular meeting on January 12, 2022 at 6:30pm via zoom only. A special meeting of the Parks, Tree & Recreation Advisory Board will be held on January 13, 2022 at 6:30pm to finalize a prioritized recommendation from the board to the Laramie City Council. A resolution supporting this recommendation will be submitted to the Laramie City Council in February for consideration. Following the passage of a resolution from the Laramie City Council packets will be delivered to the Albany County School District for review by the Albany County Recreation Board and the Albany County School District on or before March 1, 2022.

This year 15 applications totaling \$450,279.30 were received. All applicants were notified of the presentation schedule through the application process and via email on December 29, 2021.
