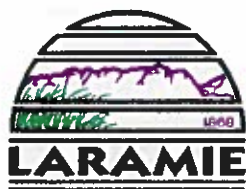

We received seventy-eight (78) applications, eleven (11) applicants were disqualified due to age requirements or a Primary Rejection Criteria. twenty-nine (29) applicants voluntarily withdrew, that left thirty-eight (38) applicants eligible to test.

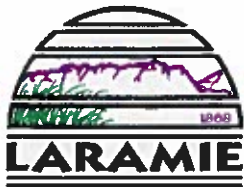

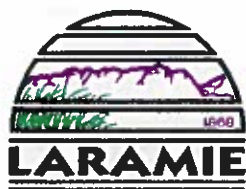

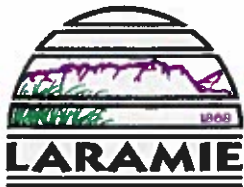
