**Title: Approving the Submission of a Grant Agreement for Airport Coronavirus Relief Grant Program (ACRGP) Concessions Relief Addendum by Laramie Regional Airport**

That Council approve the submission of a Grant Agreement for Airport Coronavirus Relief Grant Program (ACRGP) Concessions Relief Addendum by Laramie Regional Airport and authorize the Mayor and City Attorney to sign.

**Background:**

Laramie Regional Airport is seeking a grant from the U.S. Department of Transportation Federal Aviation Administration in an amount not to exceed \$4,068 through the Airport Coronavirus Relief Grant Program (ACRGP).

“This ACRGP Grant is provided in accordance with the Coronavirus Response and Relief Supplemental Appropriations act (CRRSA Act or “the Act”), Division M of Public Law 116-260.”

“This ACRGP Concessions Relief Addendum hereby amends 3-56-00170041-2021 for the purpose of adding \$4,068 for Laramie Regional Airport to use to provide relief from rent and minimum annual guarantees (MAG) obligations, as applicable, to each eligible airport concession in an amount that reflects eligible airport concession’s proportional share of the total amount of the rent and MAGs of all eligible airport concessions at Laramie Regional Airport as further defined herein, for relief provided no earlier than December 27, 2020, until the specified Concession Relief funds have been fully expended.”

“NOW THEREFORE, in accordance with the applicable provisions of the Coronavirus Response and Relief Appropriations Act, Public Law 116-260, Division M, the representations contained in the ACRGP Concessions Relief Addendum Application, and in consideration of, (a) the Sponsor’s acceptance of this Offer for an ACRGP Concessions Relief Addendum, the terms, conditions, and assurances of which are hereby attached to and made part of the terms, conditions, and assurances of which are 041-2021 and, (b) the benefits to accrue to the United States and the public from the accomplishment of the ACRGP Concession Relief Addendum, and in compliance with the conditions and requirements as herein provided.”

“The Federal Aviation Administration, for and on behalf of the United States, hereby offers and agrees to pay 100% percent of the allowable costs incurred accomplishing ACRGP Concessions Relief as a result of and in accordance with this ACRGP Concession Relief Addendum.”
