In November of 2019 the City awarded the Professional Services Agreement for the design of the North Campus Water Main project to AVI Engineering. AVI has completed the design of the project and assisted the City with obtaining an easement agreement for the utility installation.

The North Campus Water Main project has been publicly advertised and bids were opened on May 11, 2021. With the design complete and bids received AVI has put together a scope of services to perform construction inspection services.
