

ACTION: Consider One Hundred Thirteen (113) Funding Recommendations for Chapter 41 – Water and Sewer ARPA Grants

AUTHORITY: 2022 Wyoming Session Laws, Chapter 50 § 3(d) and State Loan and Investment Board Rules, Chapter 41 – Water and Sewer ARPA Grants

ALTERNATIVES: Approve or Deny Grant Requests

BACKGROUND:

The American Rescue Plan Act (ARPA) Water and Sewer Program was created during the 2022 Budget Session of the Wyoming Legislature (2022 Wyo. Sess. Laws Ch. 50). That legislation appropriated fifty million dollars (\$50,000,000.00) to the Office of State Lands and Investments (OSLI) from the State and Local Fiscal Recovery Fund for grants to be awarded by the State Loan and Investment Board (Board) for eligible water and sewer projects. Per footnote 18 in the legislation, the appropriation is for the following:

- 1.) Competitive grant funding to cities, counties, special districts and tribal governments for eligible water and wastewater projects,
- 2.) The maximum grant for any single project is seven million five hundred thousand dollars (\$7,500,000.00), and
- 3.) Each grant is conditioned upon a match of funds in the ratio of eighty-five cents (\$.85) of grant funds to not less than fifteen cents (\$.15) from matching funds.

All grants issued by the Board must meet all applicable federal eligibility. Per ARPA, funds must be obligated by December 31, 2024 and fully spent by December 31, 2026. Furthermore, ARPA funds may only be used for costs incurred on or after March 3, 2021.

The Board promulgated Chapter 41, Emergency Rules, for the administration of the APRA Water and Sewer Program (Program). The Chapter 41 Emergency Rules are based on Guidance provided by the US Treasury Department and the requirements of the authorizing state legislation. The rules are drafted to strictly comply with both federal and state law.

The Chapter 41 Rules require the Board to consider the following criteria when awarding a grant:

- 4.) Whether the project is an eligible expenditure under applicable State and Federal law;
- 5.) Whether the project will inure to the benefit of the citizens of the State; and
- 6.) Whether the project represents a prudent use of the funds.

ANALYSIS:

One hundred thirteen (113) applications totaling \$225,481,868 for the Program were accepted between July 1, 2022 and August 12, 2022. The applications were either received directly by OSLI or submitted to OSLI electronically through the State's ARPA portal, which is managed by the Wyoming Budget Department. Each submitted application has been reviewed for ARPA eligibility by the Wyoming Budget Department and its consultant, Clifton Larson Allen, and by representatives from the Wyoming Attorney General's Office, in accordance with federal and state regulations.

Per Chapter 41 Rules, Section 9(b), OSLI has calculated a score for each project application to assist the Board in prioritizing eligible projects. Additionally, a technical

review of all applications was completed by the Wyoming Water Development Office (WWDO) and Wyoming Department of Environmental Quality (DEQ) for eligibility, feasibility, and compliance issues. As required by the Board's rules, OSLI is providing a list of all applicants ranked by raw prioritization score. If the Board wishes, it may award funding on the basis of raw scores.

Additionally, OSLI, in consultation with DEQ and the WWDO, has provided a slightly modified recommended funding list in an effort to make the best use of the available funds, in light of the fact that the total amount requested under the Program was substantially higher than the fifty-million-dollar (\$50,000,000.00) appropriation. OSLI and its partner agencies applied the following principles to the raw score list to arrive at the recommended funding decisions:

- The raw priority score, calculated utilizing the criteria in Chapter 41 § 9(b), was the initial starting point for the funding recommendations.
- If an applicant submitted multiple applications, only the 1st priority application was considered.
- OSLI and the partner agencies then considered all applications in each score band (*i.e.*, all applications that with the same raw score) beginning with the highest score band. If enough funding remained to fully fund each project in the score band, each project was recommended for funding and OSLI moved on to the next highest score band. Using this methodology, all 1st priority projects scoring 18 points or higher were recommended for full funding.
- At the 17-point score band, the remaining project funds were insufficient to fund all 1st priority projects in the score band. OSLI and the partner agencies recommended funding of the applications scoring 17 points, beginning with the smallest request. This allowed nearly all 17-point applications to receive funding.
- When program funding was insufficient to fully fund the last 17-point application, OSLI and the partner agencies decided to recommend awarding the remaining funds to that application as a partial funding grant. Under this methodology, all applications scoring 17 points were able to receive at least partial funding.

OSLI now offers one hundred thirteen (113) recommendations for Water and Sewer ARPA Grant funding amounting to \$225,481,868 for the Board's consideration (See, attachments). Detailed below are nineteen (19) applications recommended for funding -- eighteen (18) for full funding and one (1) for partial funding. Due to the limited available funding, the remaining ninety-five (95) applications are not recommended for funding. (See, attached spreadsheets for more detail).

Furthermore, it is the responsibility of all applicants who receive funding from Chapter 41 of the Board's Rules and Regulations, Water and Sewer ARPA Grants, to comply with all provisions of ARPA and the companion Wyoming legislation. If it is determined that any expenditure is not in compliance with the governing regulations, funds awarded from the

Water and Sewer ARPA Program must be returned by the applicant to OSLI within fifteen (15) business days of notification.
