

Entitled: A RESOLUTION AUTHORIZING SUBMISSION OF A CORONAVIRUS RELIEF GRANT APPLICATION TO THE STATE LOAN AND INVESTMENT BOARD ON BEHALF OF THE GOVERNING BODY FOR THE

FOR THE PURPOSE OF:

Upgrading the mechanical systems to improve the indoor air quality of the buildings, protect the safety of the Public and to reduce the propagation and spread of biological contaminants, which includes the Coronavirus. These contracted expenditures are for HVAC/CLEAN buildings at City facilities in order to improve air technologies such as Ultra-Violet Germicidal Irradiation (UVGI) and negative ionization which can damage the genetic materials in the nucleus of cells of microorganisms, including bacteria, mold and viruses.
