Title: Renewal Retail Liquor License No. 8 Coppers Bar LLC dba Coppers Liquor Lounge

Recommended Council MOTION:

That City Council approve the application for renewal of Retail Liquor License No. 8 from Coppers Bar LLC dba Coppers Liquor Lounge, 867 N. 3rd Street, Laramie, Wyoming for the licensing term May 8, 2021 thru May 07, 2022, and authorize the Mayor and City Clerk to sign the license.

Background:

Application for a renewal of Retail Liquor License No. 8 from Coppers Bar LLC, was filed in the City Clerk's Office on March 16, 2021. The premise location for the license is 867 N 3rd St. Laramie, Wyoming.

LMC 5.09.425 On all days, a licensee may open the dispensing building or room at six a.m. and shall close the dispensing room or building and cease the sale of both alcoholic and malt beverages promptly at the hour of two a.m. the following day and shall clear the dispensing room or building of all persons other than employees by two-thirty a.m.

LMC 5.09.610 Persons under twenty-one years of age-Prohibited on licensed premises- Exceptions for Retail Liquor Licenses. (Please review full section of code.)

LMC 5.09.615- Prohibited on licensed premises- General Exceptions. (Please review full section of code.)

LMC 5.09.615.A.5. The establishment is operating a restaurant and the primary source of revenue (greater than 50% of revenue) of the operation is from the sale of food.

Retail Liquor License holder may sell for off-premise consumption.

Alcohol Catering permits may be applied for to serve alcoholic beverages off-premise. Serving off-premise without a permit is punishable under the Point System.

- Must complete an approved application for liquor license accompanied by all required documents. New licenses must provide:
 - o application (LMC 5.09.105.A)
 - o floor plan (LMC 5.09.105.B)
 - o TiPS Training report (LMC 5.09.105.G)
 - o lease, if applicable (W.S. 12-4-103(a)(iii))
 - o application fee of \$50 (LMC 5.09.140)
 - o statement indicating the financial condition and financial stability of the applicant (W.S. 12-4-102 (a) (vi))

The application documentation presented appears to be complete. All required attachments have been received by the City including the Annual Alcohol Server Training Report. Advertisement requirement has occurred. Wyoming Liquor Division has certified the application as complete. [W.S. 12-4-104(d)].

Legal/Statutory Authority:

Requirement of W.S. 12-4-101 (a) and Laramie Municipal Code that “Incorporated cities, towns and counties within Wyoming shall license and regulate or prohibit the retail sale of alcoholic and malt beverages under this title..... or from refusing to issue any license or permit authorized by this title.”
