Third and Final Reading (Introduced by Shuster)

MOTION BY PEARCE, seconded by Stoner, to approve Original Ordinance No. 1977 on third and final reading; amending Title 12 of Laramie Municipal Code, 12.08.020 – Snow, ice and debris – Removal from sidewalks; based on findings of fact and conclusions of law, and authorize the mayor and clerk to sign the ordinance.

MOTION BY GABRIEL, seconded by Stoner, to change on a snow event that occurs before 12:00 a.m. midnight to have the snow or ice to be removed from sidewalks by 9 a.m. to 12 p.m. noon the following day (Section 1, LMC 12.08.020).

MOTION BY STONER, seconded by Shumway, to change the wording in LMC.12.08.020, Section 1, paragraph 2, to state “the owner shall be charged the contractor’s fee plus a \$50.00 administrative fee.”
