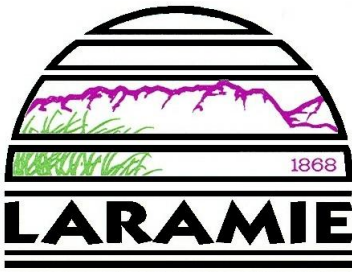

The applicant must complete all the work described for this permit in accordance with the approved plans, all provisions of the Laramie Municipal Code, the latest edition of the Wyoming Public Works Standard Specifications, and other applicable laws, rules, and regulations of the City of Laramie.
3. The applicant must provide advanced notice of all required inspections.
4. A traffic control plan will be required with this application if any obstruction of the public right of way will occur (street, alley, sidewalk).
5. A street closure application will be required with this application if a street will be closed.
