General Information:

City services and recycling are billed monthly. There is no deposit required; however, base charges for water, sewer, garbage and recycling services, and mosquito control are billed in advance. Water and sewer consumption are billed the following month and are based on actual meter readings.

Owner:

The Laramie City Code provides that the property owner and/or the agent, tenant, purchaser, and/or lessee of such place of abode or place of business shall each and all be jointly and severally liable for the payment of all charges and fees hereunder. Failure to pay any charges and fees when due shall constitute a violation of the provisions of this chapter. Collection of the charges and fees fixed under this Code when delinquent may be enforced by civil action at law brought by the City and/or accredited collection agency for the City in any court of competent jurisdiction, and this remedy is cumulative and not exclusive and shall be in addition to all penalties provided by this Code for any violation of any provisions hereof. No change of ownership or occupation shall affect the application of the Section.

If you elect to have your tenant receive a duplicate bill and they fail to pay the charges in full, you will receive a written notice mailed to you at the mailing address provided on the front side of this form stating that charges have not been paid and that the services may be terminated. If services have been terminated for non-payment, there will be an administrative fee to restore services. Please note: payment responsibilities and arrangements between landlords and tenants constitute a civil agreement to which the City of Laramie is not a party. Ultimately, the property owner is responsible for the utility account.

I hereby acknowledge that I am the owner of this property and agree to be responsible for payment of municipal services until I notify the City of Laramie Utility Billing Department otherwise.
