

**CITY OF LARAMIE, WYOMING
RESOLUTION 2021-48**

**A RESOLUTION SETTING THE LIQUOR LICENSE MASTER FEE SCHEDULE,
WITH AN EFFECTIVE DATE OF JULY 1, 2021 AS INDICATED IN ATTACHMENT A.**

WHEREAS, various fees and charges have existed for liquor licenses within the City of Laramie for many years, and these fees and charges have been modified at various times, and;

WHEREAS, some liquor license fees were last modified effective July 1, 2019, and;

WHEREAS, House Bill 0013 and House Bill 0156 added Off-Site permits for Winery and Manufacturer Permits in accordance with Title 12 effective July 1, 2021, for a fee of not less than ten dollars (\$10.00) not more than fifty dollars (\$50.00) per twenty-four (24) hour period; and

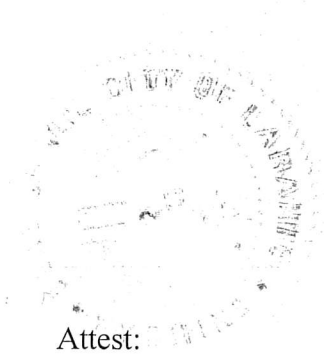
WHEREAS, staff recommend the same amount that is currently charged for alcohol catering and malt beverage permits per twenty-four (24) hour period.

NOW THEREFORE, THE CITY COUNCIL OF LARAMIE, WYOMING RESOLVES:


Section 1: That the foregoing recitals are incorporated in and made a part of this resolution by this reference.
